## **NEW BUSINESS**

Dorrel discussed with the board the Friends of Gallatin Cupola Account that was set up for the Disaster Grant for the Cupola building. Dorrel explained with the grant not being awarded to the Friends of Gallatin Downtown Improvement Group the account needed to be closed, and all proceeds transferred to the Friends of Gallatin Downtown Improvement account.

King made a motion to approve closing the Friends of Gallatin Cupola Account and transferring all proceeds from that account to the Friends of Gallatin Downtown Improvement account. Curtis seconded the motion.

3. Electric- continued working on several locates daily for Windstream. Worked with employees at the water plant. Repaired underground wire that was hit by a contractor.

Worked on the heater at the power plant.

4. Streets- Staff continued mowing various properties, worked at the water plant. Helped with the repair on the underground wire. Worked on equipment maintenance and winterization.
