

ORDINANCE NO. 900

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HUDSON, IOWA, BY REPEALING PROVISIONS PERTAINING TO ONE WAY TRAFFIC

Be It Enacted by the City Council of the City of Hudson, Iowa:

SECTION 1. SECTIONS MODIFIED. Sections 68.01 of the Code of Ordinances of the City of Hudson, Iowa, are repealed and the following adopted in lieu thereof:

68.01 ONE-WAY TRAFFIC REQUIRED.

Upon the following streets and alleys, vehicular traffic, other than permitted cross traffic, shall move only in the indicated direction when appropriate signs are in place.

(Code of Iowa, Sec. 321.236[4])

School Street between South Washington Street and South Jefferson Street.

SECTION 2. SEVERABILITY CLAUSE. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 3. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.


